Presentations: NOCFA Fire Fighters Association J.P. Kravetz -

The North Oakland County Firefighters Association Hereby Resolves:

Whereas a Vote of No-Confidence is an alternative method to bring forth serious concerns of public safety and mismanagement to the public, while still promoting uninterrupted and dedicated service, because such services are vital to the welfare and public safety of the residents of Holly Township and Rose Township and, Whereas by a unanimous vote of the Firefighters who belong to the North Oakland County Firefighters Association, we believe that this No Confidence Resolution is but one of those very limited options available to promote these purposes and,

Whereas and listed below, are reasons why the membership of the North Oakland County Firefighters Association have NO CONFIDENCE in the North Oakland County Fire Authority Board of Directors Chairperson and Citizen at Large, Peter Stouffer:

- 1. The Chairperson/Citizen at Large through both informal and formal processes has routinely undermined the Fire Authority, through parliamentary maneuvering, information suppression, and covert intimidation, creating an environment contrary to the forward-looking management style needed to address the challenges facing our fire department. These include:
- Supporting funding and budgeting decisions that have undermined the morale of the Firefighters and compromised the safety of the Department members and our citizens,
  - Falsely accusing another Board member of a Federal Crime,
  - Implementing actions to suppress spontaneous input from Officers during Board meetings,
- Excessive and unprecedented requests to utilize legal counsel, resulting in thousands of dollars in legal fees,
- Allowing in-fighting and petty grievances among board members, which threatens the ability of the two townships to govern together in a responsible way to ensure the continuation of the Authority as an ongoing Fire District,
  - Showing to have a general disregard for the sanctity of the democratic process,
- 2. The legal definition of "Citizen at Large" is "a person who does not represent a specific organization and is a resident of the member municipality,"

• As the Chairperson/Citizen at Large, Peter Stouffer, has been appointed to the Rose Township Zoning Board of Appeals, he now concurrently holds a formal position for one of the Townships which diminishes his independence and, as such, no longer meets the intent of a Citizen at Large.

Whereas the reasons for this vote include, lack of leadership, bullying of fellow Board members, failure to respond to firefighter and citizens' concerns, fiscal decision-making priorities, the appearance of biased support of Rose Township motions, and lack of overall concern for the well-being and continuation of the Fire Authority. The members of the North Oakland County Firefighters Association believe that Chairperson/Citizen at Large, Peter Stouffer, should resign immediately and the process for replacement be started as such.

Our goal is not to create acrimony or compromise the safety of our communities, but to share our concerns so we can improve the Department and provide for the continuation of the quality of service we have been delivering to the community and which they expect and deserve. Despite this crisis, the North Oakland County Fire Authority Fire Fighters' will continue to stand strong in protecting life and property and remain committed to the public we serve.

Furthermore, as many of the members of the North Oakland County Firefighters Union IAFF Local 5346 are also members of the North Oakland County Firefighters Association, the members of NOCFFU Local 5346 do abstain from the vote on the motion that creates this resolution. The membership of the union would like to remain neutral in this matter.

#### **Reports:**

Treasurer Freeman - The last day to pay taxes without penalty was February 14, 2022, and the last day to pay taxes at the Holly Township offices is February 28, 2022. After March 1, 2022 unpaid taxes will be transferred to the County.

Supervisor Kullis - Reported that he will be calling a special meeting regarding NOCFA. To date, the NOCFA Board has incurred \$15,000 in attorney fees and is an unfunded mandate in the budget.

He met with the Mott Family regarding the Farmstead and they are in support of hiring a project manager. HRC has completed the engineering report. Oakland County will be conducting the Perk Test, however, it will need to be rescheduled as the two previous were canceled.

The Holly Schools Bond Proposal will be presented at the monthly Holly Chamber of Commerce Breakfast on Friday, February 25, 2022.
