<p>Shall the Village of Holly be authorized to levy and collect a new special assessment on all taxable parcels in the Village in an amount of three (3) mills per \$1,000 of taxable valuation (\$3.00 per \$1,000 of taxable value) for a period of fifteen years from 2022 through 2036, inclusive, for police/fire public safety operations in the Village? The special assessment is estimated to produce a minimum of \$378,000 in collections in the first year of the levy.</p>
