**RESOLUTION 2023-09**  
**PETITION TO THE DRAINAGE BOARD FOR THE NORTHWEST**  
**OAKLAND DRAIN PROJECT**

BE IT RESOLVED BY HOLLY TOWNSHIP, OAKLAND COUNTY,  
MICHIGAN, as follows:

1. In reliance on the Oakland County Water Resource Commission's (WRC) assurances and based on the WRC Presentation dated May 16, 2023, attached hereto as Exhibit A and made a part hereof, that Holly Township make and cause to be filed a petition in form substantially as follows:

**PETITION**

**TO THE DRAINAGE BOARD FOR THE NORTHWEST OAKLAND  
DRAIN PROJECT**

The undersigned public corporation petitions for Phase 1 of the location, establishment, and construction of an intra-county drain project known as the Northwest Oakland Drain Project (the "Project"), which drain project is necessary for the public health, to extend sanitary sewer service from the Oakland County border with Genesee County to serve certain properties located within the Village of Ortonville, Groveland Township, Brandon Township, and Holly Township (collectively, the "Communities"). The Northwest Oakland Drain Project will collect and transport sanitary wastewater originating in the County of Oakland only, to be transported to the border with Genesee County and will provide future capacity to serve the Communities and better protect the environment.

This petition consists of the following first phase of an intended three-phase process for the Project (the portion as described herein is the "Phase 1 Project"):

The Phase 1 Project includes an exploration of, and request for, applicable grants and other funding sources for the Project.

The Phase 1 Project also includes the negotiation and preparation of an agreement or agreements between the Drainage District to be established pursuant to this petition process and the County of Genesee providing, without limitation, for the right to place sanitary flow to a sewer line of appropriate capacity located in

Genesee County that will be extended to the Genesee County and Oakland County border, which agreement or agreements shall expressly limit the cost for the negotiation and preparation of said agreement or agreements to the amount to be provided by the County of Oakland from ARPA grant funds, which is estimated to be \$10 million.

Said Phase 1 Project is necessary for the public health and will serve property entirely within the Communities.

This petition is filed pursuant to the provisions of Chapter 20 of Act No. 40 of the Public Acts of Michigan of 1956, as amended.

It is understood and agreed that the final cost of the Phase 1 Project, if any, including litigation costs and the amount of any judgment, arbitration award or settlement, to the extent such costs are payable by the Drainage District, shall be allocated against this petitioner and all other public corporations that benefit from the Phase 1 Project and contribute to the conditions that make the Phase 1 Project necessary.

The issuance of bonds to finance the Phase 1 Project contemplated herein is contingent upon the Communities and the proposed drainage district entering into an agreement as provided by law setting forth the services and operations of the proposed drainage district and to provide for methods of addressing and apportioning future improvements to the proposed drainage district.

A certified copy of the resolution of the governing body of Holly Township authorizing execution of this petition is attached hereto.

That the Supervisor and Clerk are hereby authorized and directed to execute this petition for and on behalf of Holly Township and to execute an agreement related to the Phase 1 Project contemplated by this petition and to file the same with the Water Resources Commissioner of the County of Oakland.

4. That the Township Board consents to an assessment, if necessary, of the Township's share of the entire cost, if any, allocated against the Township.

5. The Township acknowledges County of Genesee will be providing a sewer line of appropriate capacity located in Genesee County that will be extended to the Genesee County and Oakland County border at an estimated cost of \$35.0 million to Genesee County. The Township further acknowledges that the County of Oakland, its Board of Commissioners, and the Oakland County Water Resources Commissioner will not contribute to the cost of the Phase I Project or its operation and maintenance except as described in paragraph 2 of the petition and to the extent that the County of Oakland may be assessed for the cost of the Phase I Project or may agree to contribute to the cost of the Phase I Project in accordance with the provisions of Chapter 20 of Act No. 40 of the Public Acts of Michigan of 1956, as amended.

6. That all prior resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution are rescinded.

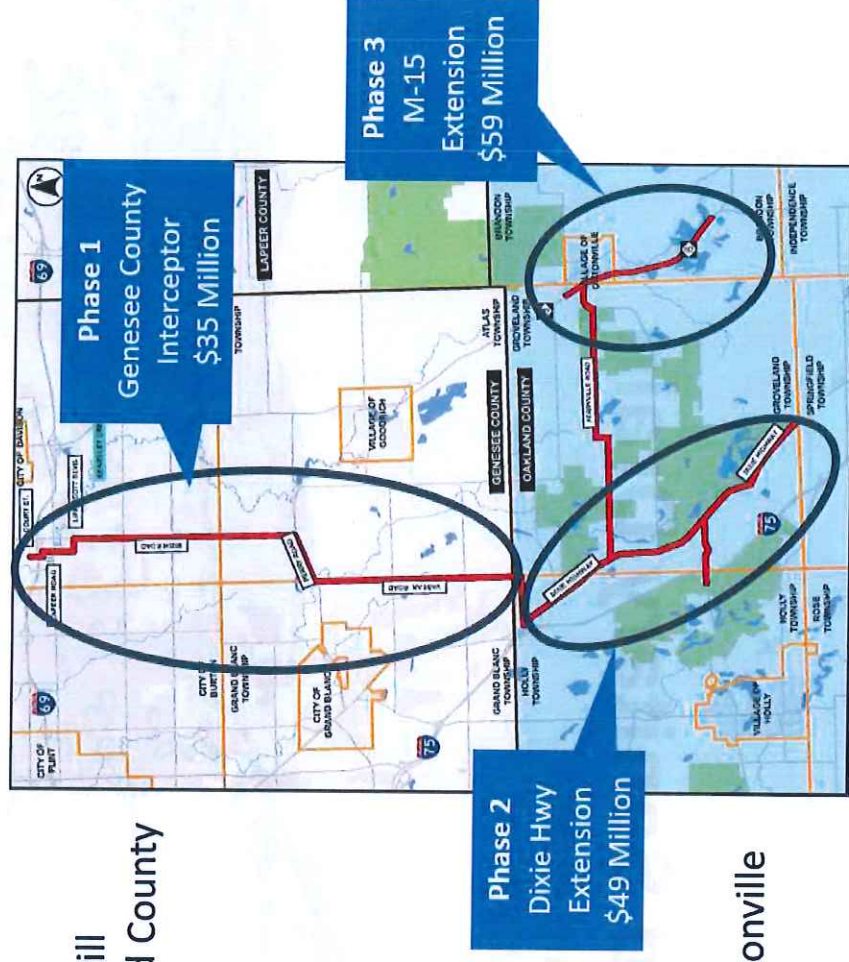

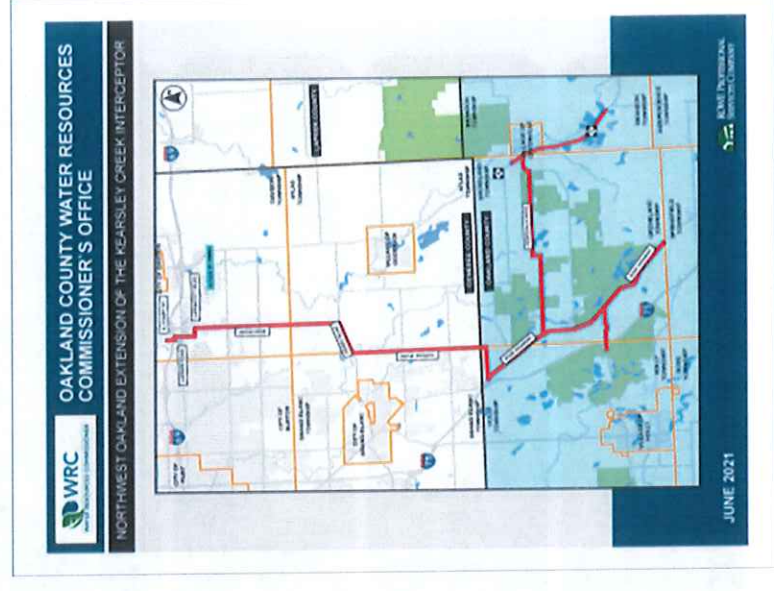

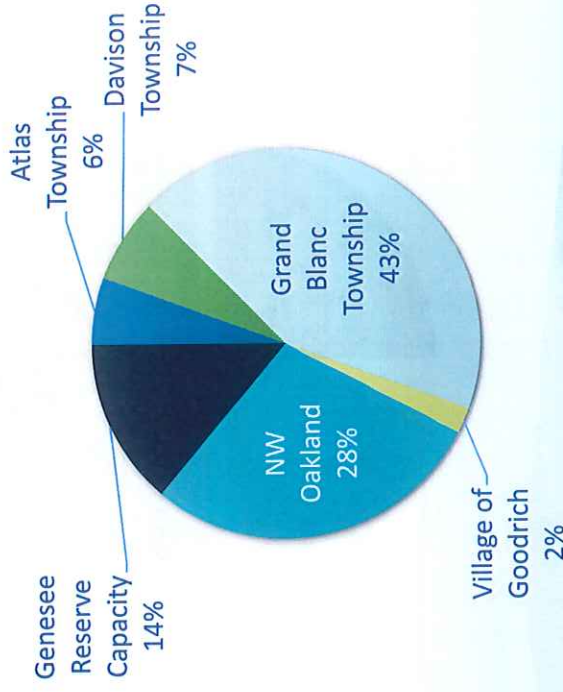

**Initial Contract Capacity by Customer**

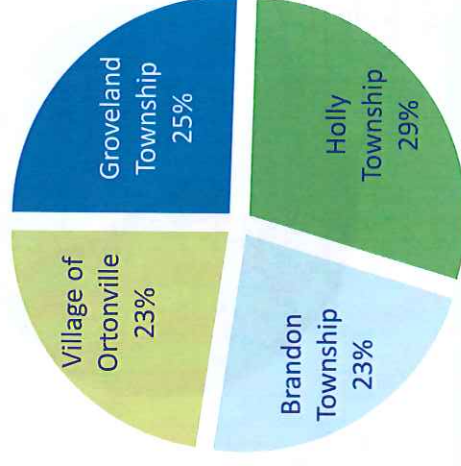

# Phase 1 Petition

## Why is a petition needed?

- Mechanism and part of the WRC continued process to keep Communities informed and a way for the communities to Demonstrate support for the project and initiate the first phase of the project.
- Like the first petition to create the district, this petition has no budgeted costs to apportion.

## What does the petition do?

- Continuation of the project with the following limited scope:
  - Seek outside grant funds for the project
  - Negotiate agreement for purchase of sewer capacity in the \$35 million Genesee County Project for NW Oakland
  - Limits costs to the Drainage District through reference to the Purchase Agreement
- Drainage District to finalize the agreement with Genesee County once the petition process is completed.

## When is the next petition needed?

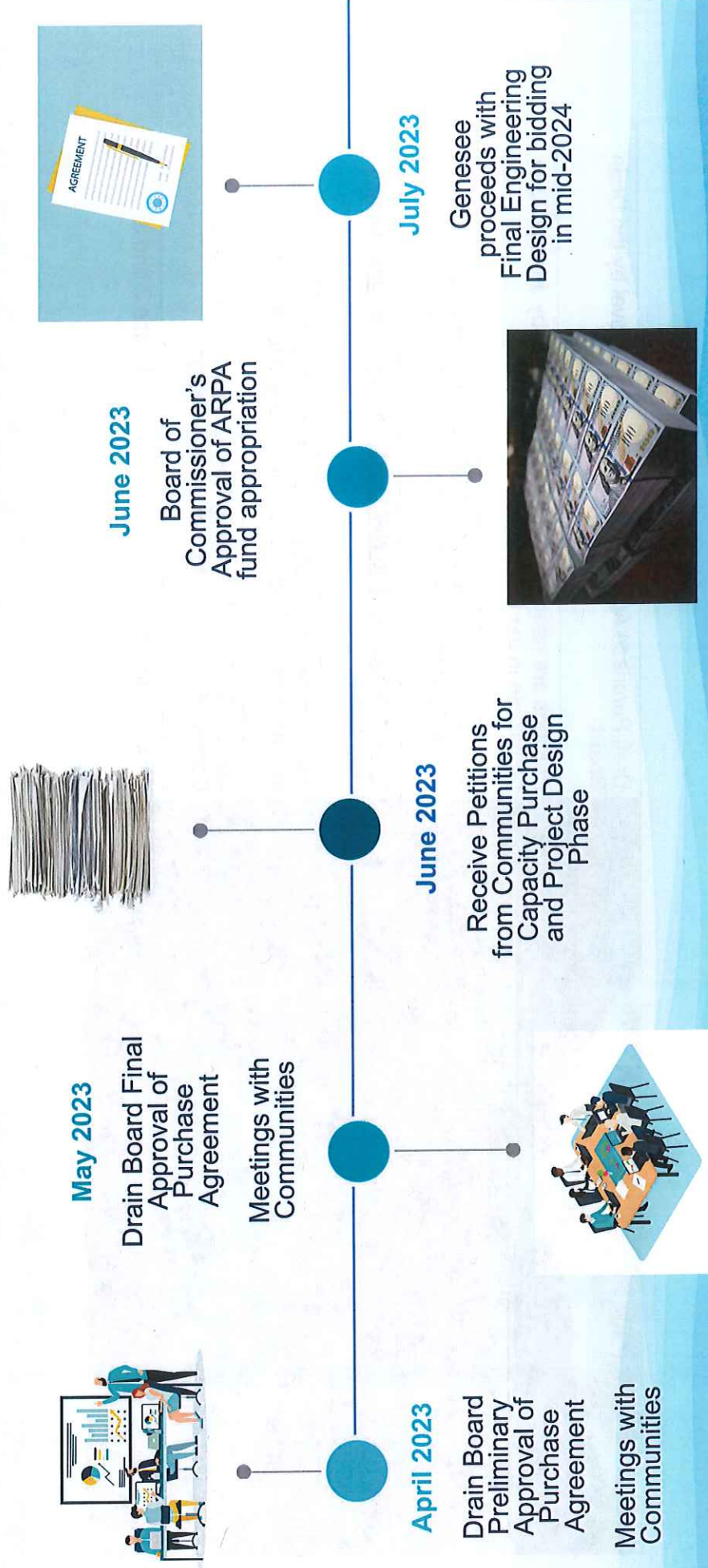
- Before Phase 2 construction once funding mechanism has been identified.

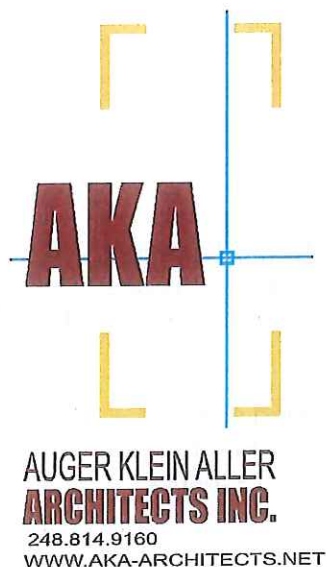

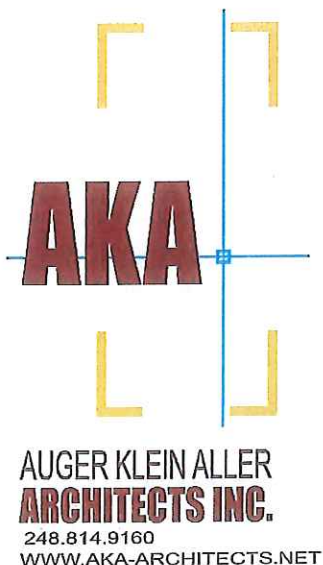

HRC's proposal dated July 20, 2021 detailed the design effort to begin implementation of the Farmstead Master Plan, Phase 1. The total for this proposal was \$25,000

- ≡ Part 1 of the scope of services was to provide a list of available grants with funding levels and assist the Township with grant applications.
- ≡ Part 2 was to assist with site preparation. Specifically Parking, Access and internal circulation. These were specifically for:
  - Ingress/egress points for the main parking area, 4-H area, and the event barn.
  - Grading and drainage for the 4-H parking area, main parking lot and access roads
  - RCOC permit for site access.
- ≡ Part 3 was for Fence design and planning along N. Holly Road. For this task, HRC had McKenna and Associates as a subconsultant to assist with fence types and placement.

A revised proposal was prepared in August of 2021, adding additional site and utility design. The cost of this proposal was \$44,500. In September of 2021, the site survey was conducted (South portion was not surveyed). Additionally in September of 2021, fence options were provided by McKenna and Associates for review by the Township.

In January of 2022, HRC prepared a potential layout for the septic system looking ahead to plan to take on waste from the event barn, future Township Hall building, and 4-H area. We also coordinated with the Oakland County Sanitarian to conduct percolation testing in order to know what type of septic system will be needed, the design parameters, and cost to plan for. The percolation testing took place in March of 2022. These tests showed that the soils are not conducive for infiltration, so the system that will be required for this project is a pressurized, engineered system.

In July of 2022, the Township hired AKA Architects to begin work on the conceptual plan for the Township Hall building. With the start of the actual Township Hall building work, this shifted the HRC scope to assist in supporting the AKA work. Multiple meetings followed to assist the architect with siting the building and working on conceptual grading. It was determined that soil borings would be required on the site at this time, a proposal from G2 consulting was provided to the Township and subsequently approved for \$13,200. HRC hired G2 Consultants to perform soil borings. These borings were specifically to assist with the building location and foundations. Boring locations were taken in separate locations where there was potential to put the building, site access and parking lot to support the design these design efforts-.

In September of 2022, the potential for the Township to purchase the property across N. Holly Road became apparent. This would change some of the requirements on the Farmstead property. As such, the current direction for the Township Hall and parking area project is awaiting confirmation on the property on the West side of the road.

Additional work has been completed such as staking for the Ernst Barn. HRC survey staff staked the SW building corner as well as the proposed building alignment so that the Barn contractor can begin moving the Ernst Barn from the Oakalnd County Parks property to the Farmstead.

The remaining funds can be used to complete and tasks and continue to assist the Township. A new proposal will be submitted for construction once some clarifications of the scope are decided.



## **DIVISION 2. ZONING BOARD OF APPEALS\***

**\*Cross references:** Boards and commissions, § 2-111 et seq.

**State law references:** Zoning board of appeals, MCL 125.288 et seq.

### **Sec. 32-61. Authority.**

There is established a zoning board of appeals, the membership, powers, duties of which are prescribed in Public Act No. 110 of 2006. The zoning board of appeals in addition to the general powers and duties conferred upon it, by Act No. 110, in specific cases and subject to appropriate conditions and safeguards, shall interpret and determine the application of the regulations established under this chapter in harmony with their purpose and intent as set forth in this chapter.

### **Sec. 32-62. Membership.**

The zoning board of appeals shall consist of five members, appointed by the township board.

(1) The first member of the zoning board of appeals shall be a member of the township planning commission.

(2) The second member of the zoning board of appeals shall be a member of the township board.

(3) Three additional members of the zoning board of appeals shall be selected from among the electors residing in the unincorporated area of the township.

(4) An employee or contractor of the township board shall not serve as a member of the zoning board of appeals.

(5) The terms of membership for zoning board of appeal members shall be three years, except for members serving because of their membership on the planning commission or township board, whose terms shall be limited to the time they are members of the planning commission or township board, respectively, and the period stated in the resolution appointing them. A successor shall be appointed not more than one month after the term of the preceding member has expired.

(6) All vacancies for unexpired terms of the zoning board of appeals shall be filled by appointment of the township board for the remainder of such term.

(7) Members of the zoning board of appeals shall be removable by the township board for nonperformance of duty or misconduct in office upon written charges and after public hearing.

(8) A township board may appoint not more than two alternate members of the zoning board of appeals for the same term as regular members to the zoning board of appeals. An alternate member may be called by the chairman of the zoning board of appeals to serve as a regular member of the board in the absence of a regular member if the regular member is absent from or will be unable to attend one or more consecutive meetings of the board or is absent from or will be unable to attend meetings for a period of more than 30 consecutive days. An alternate member of the zoning board of appeals may also be called to serve as a regular member for the purpose of reaching a decision on a case in which the regular member has abstained for reasons of conflict of interest. The alternate member appointed to the zoning board of appeals shall serve in the case

This Agreement, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2023, by and between the Board of County Road Commissioners of the County of Oakland, Michigan, hereinafter referred to as the BOARD, and the Township of Holly, hereinafter referred to as the HOLLY, provides as follows:

WHEREAS, the BOARD and HOLLY have agreed to program the spreading of gravel and chloride on various roads under the jurisdiction of the BOARD, as described in Exhibit "A", attached hereto, and made a part hereof, the roads selected will be mutually agreed upon by the BOARD and HOLLY, which are hereinafter referred to as the PROJECT; and

WHEREAS, the estimated total cost of the PROJECT is \$60,689; and

WHEREAS, the PROJECT involves certain designated and approved Tri-Party Program funding in the amount of \$60,689 which amount shall be paid through equal contributions by the BOARD, HOLLY, and the Oakland County Board of Commissioners, hereinafter referred to as the COUNTY; and

WHEREAS, HOLLY and the BOARD have reached a mutual understanding regarding the cost sharing of the PROJECT and wish to commit that understanding to writing in this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein, it is hereby agreed between HOLLY and the BOARD that:

1. The BOARD shall forthwith undertake and complete the PROJECT, as above described, and shall perform all engineering, inspection and administration in reference thereto.



2. The actual total cost of the PROJECT shall include total payments to the contractor. Any costs incurred by the BOARD prior to this agreement date shall be allowable.
3. The estimated total PROJECT cost of \$60,689 shall be allocated as follows:
  - a. Tri-Party Program funding in the amount of \$60,689.
  - b. Any PROJECT costs above the Tri-Party Program funding of \$60,689 will be funded 100% by the BOARD.
4. Upon execution of this Agreement, the BOARD shall submit an invoice to HOLLY in the amount of \$20,230 (being 100% of HOLLY'S Tri-Party contribution).
5. Upon execution of this agreement and approval by the COUNTY, the BOARD shall submit an invoice to the COUNTY in the amount of \$20,230 (being 100% of the COUNTY'S Tri-Party contribution).
